**COURSE DESCRIPTION AND OBJECTIVES**

Brain Health Journal Club is a 1 credit hour course with an emphasis on brain health. The scope of the journal club is broad, with topics ranging from molecular mechanisms of drugs to behavioral studies. On a rotating basis, participants will be expected to present to the group either a paper of interest and relevance to their work or an update on their ongoing research or some combination of the two. PowerPoint slides are discouraged in favor of a chalk talk format when presenting to the group.

**Semester credit hours** – 1

**COURSE ORGANIZATION**

The main teaching modalities used in this course include:

- 1) **Auditory activities: participating in discussions, listening to oral presentations**
- 2) **Visual activities: interpreting graphs, figures and tables**
- 3) **Tactile/kinesthetic activities: writing on the whiteboard, drawing schematic overviews of subject matter**
