# **COURSE DESCRIPTION AND OBJECTIVES**

The advanced education student is assigned for two days per week for four consecutive weeks to the Department of Pediatrics at the Children's Hospital of San Antonio and Laredo Medical Center Hospital. During the rotation, the student participates as a hospital housestaff in the General Pediatrics in-patient service to include rounds, house call, patient clinics of cardiology, hematology, renal, neurology, and oncology. The rotation is designed to conform with the AAPD guidelines for pediatric medicine by providing the environment to emphasize a thorough, accurate history, and physical examination and to give the dentist as much opportunity as possible to improve skills in taking, recording, and presenting a history and physical, and in using the information to arrive at reasonable possible diagnoses.

## **LEARNING OBJECTIVES:**

Each advanced education student will obtain knowledge and experience in the medical health management of infants, children and adolescents in a hospital environment. As a result of the pediatric medicine rotation, students will be able to:

- 1.) Perform medical histories and physical examinations.
- 2.) Perform clinical assessment procedures.
- 3.) Provide parental interviews.
- 4.) Determine a system-orientated physical health status.
- 5.) Order appropriate laboratory tests to obtain diagnostic information.
- 6.) Discuss implications of childhood diseases.
- 7.) Describe common pediatric medical diagnoses, medical management and prognosis.
- 8.) Describe medical conditions that affect the dental management of pediatric patient.
- 9.) Present a case history of a pediatric patient and considerations taken during dental treatment.

In addition, each advanced education student is required to prepare and give a presentation on a pediatric patient with a medical diagnosis. This presentation focuses on the medical condition, medical management and prognosis of the disease process. A discussion on the dental management and any modifications of dental treatment must be included in the presentation.
