COURSE DESCRIPTION AND OBJECTIVES

This course involves independent, original research under the direction of a faculty advisor. IBMS 6097-1GEN is a special lab section for first year students who have not yet committed to a particular IBMS discipline (or students who are in the process of changing disciplines). Generally, students should enroll in the research course section that corresponds to the most appropriate IBMS Disciplines: IBMS 6097-2BA for Biology of Aging (BA), IBMS 6097-3CB for Cancer Biology (CB), IBMS 6097-4CGM for Cell Biology, Genetics & Molecular Medicine (CGM), IBMS 6097-5MIM for Molecular Immunology & Microbiology (MIM), IBMS 6097-6MBB for Molecular Biophysics & Biochemistry (MBB), IBMS 6097-6NS for Neuroscience (NS), and IBMS 6097-7PP for Physiology & Pharmacology (PP). However, students who have not declared a discipline (e.g., students who must continue their laboratory rotations into the Spring semester of Year 1), should sign up for IBMS 6097-1GEN, General section. The IBMS 6097-1GEN course requires independent, original student research under the direction of a faculty mentor (could be the laboratory rotation advisor). Enrollment in IBMS 6097 with discipline designations typically requires course permissions which is granted by the discipline coordinator or director.

Semester credit hours - Variable, 1 SCH to 12 SCH

By the end of this course, each student should be able to:

- Conduct independent experiments using the appropriate experimental approaches in biomedical research to address scientific questions.
- Interpret the underlying principles, experimental design, data and statistical analyses of specific biomedical experiments.

COURSE ORGANIZATION

The main teaching modalities used in this course include:

1) Hands-on laboratory work with the purpose of addressing an important area of study in Integrated Biomedical Sciences.

<u>Materials</u> – Laboratory protocols and laboratory notebooks. Laptop for data presentations.
